Guest Speaker: Michael Woloson reported on the FLWIB Marketing Committee's annual campaign, Skills2Compete. Mike provided a flyer portraying the campaign whose mission is to create awareness of Finger Lakes job and training opportunities for middle skill jobs. Mike discussed some of the many activities being scheduled within the Workforce network as well as throughout the community to bring light to this demand for skilled workers in advanced manufacturing, healthcare, skilled trades and food/agriculture technology.

YOUTH PROGRAMS UPDATE:

- Youth Counselor Loree Martin (Yates County Workforce Development) and Deb McGrimley (Seneca County Workforce Development) shared their Summer Youth Employment Programs' youth-developed videos. Youth staff adjoined TANF (Temporary Aid to Needy Families) and WIA (Workforce Investment Act) programs to offer summer jobs opportunities that provided valuable work experience and income to economically disadvantaged local youth.

Son Farms in Seneca Falls. At the time of the meeting, 24 of the 26 Finger Lakes high schools and 37 exhibitors had already registered to participate.
