<u>New York State Regent Wade S. Norwood</u> – Regent Norwood presented on efforts to better prepare young people for college and/or the workplace. The Regent discussed common core, college and career readiness and the exposure of students to the skilled trades industry.

ENVIRONMENTAL SCANNING

Economic Issues/Trends/Concerns:

- Mr. Mueller noted the agricultural industry had a successful year. The main concern for this industry will be the recent increase in minimum wage. The industry hires summer help from high school students and this wage increase will be a topic of discussion.
- Mr. Mandina discussed the State of the State Address. The topic of tax free zones, and business taxes in general will be interesting to follow in 2014.
- Mr. Manikowski noted that the Foreign Trade zone application process by the Ontario County Economic Development Corporation is continuing.
- Mr. Rotenberg discussed the H1B Advanced Manufacturing Grant Program. One year certificate programs
 will now be approved to use the grant funds for training. Prior to this approval, the funding was strictly used
 for two year programs.

- Finance & Audit: Ms. Springmeier for Mr. Doeblin
 - The 990 and Chart 500 have been filed. The Key Highlights show the past six months through December. The RFP for audit services was sent out and will be reviewed by the committee in the upcoming weeks.
